Important Change in the Zoning Ordinance — How Will It Affect Lyon Village? How will it Affect Your Property?

The County Board is scheduled to vote on a significant change to the Zoning Ordinance that will reduce the allowable footprint size for a house and the allowable overall lot coverage. We are fortunate to have three Lyon Village residents who are working closely with the County to determine the impact of the proposed changes on all single family, detached homes in Arlington.

Come to the April 11th General Meeting to learn:

- What are the proposed new rules?
- What can you build or add now?
- How will that change under the new rules?

We will have overall data for the County, data for Lyon Village, and data for every property in Lyon Village that you can review to determine how your property will be affected. We expect to take a vote confirming the LV stance on this issue at the General Meeting. Thank you to Martha Moore, Jackie Snelling and Bill Gearhart for their work on this issue.

Funding for Improvements to Lyon Village Park

On March 23, the Arlington Park Recreation Commission approved funding for the Kinderswing in the Lyon Village Park for an application submitted last summer. The Planning and Design unit of the Department of Parks and Recreation will be putting the project out to bid in the next couple of months and hope to start the work in the park by August. We would like to thank Mary Renkey, who has been the liaison to the Parks Committee, for her work on this neighborhood improvement. Ceci Philps also deserves our thanks!

Harris Teeter on Washington Blvd

Faison has presented to the county a revised proposal for their project at Washington Blvd and Irving Street. The plan now includes a 12th St located behind 4 new townhomes facing onto 13th St. The new block of 12th St does not align with 12th St in the Hartford or Hudson blocks. Loading for the potential supermarket and 10-story residential tower would be on the new block of 12th St. Faison will be presenting their proposal at an upcoming LVCA General Meeting.

Proposed Redevelopment at the Riley House Site

Developer Chip Cross has a proposal for a new development consisting of 3 homes for the site of the current Riley house on Johnson St off Jackson. These homes would be adjacent to Mr. Cross's *Lyon Crest* development of 5 homes visible above Kirkwood Rd (currently under construction). Neighbors near the proposed development have expressed concerns regarding drainage of the site and the potential for flooding, particularly for the homes on Kirkwood Rd, downhill from the site. There is also the loss of trees and green space. The county has created a URD for the site to improve the placement of the new homes (while allowing the homes to be packed more tightly together). A number of neighbors feel that given the by-right nature of the project, the URD has provided a solution to what may be an inevitable and unfortunate loss of one of the significant older homes in Lyon Village. The proposal will be heard at the April 25 County Planning Meeting and at the May 7 County Board Meeting. These are your opportunities to be heard. News From Our March General Meeting

The March General Meeting included a number of items of importance to the LVCA community. Our association approved the Cleveland Street NCAC project. Homeowners on North Cleveland Street between Lee Highway and Key Blvd. were seeking support for a curb, gutter, sidewalk, and lighting project. In addition, the association prioritized the three outstanding NCAC projects for LV. Our first priority will be the Hudson Street project, followed by the 13th Street project and then the Cleveland Street project. The Civic Association also voted to formalize a process of prioritizing NCAC projects that has been in use for a number of years.

Lonn Henrickson provided a presentation on the evolution of the Cable TV and Information Technology Advisory Committee, including new initiatives coming soon that will speed-up internet response time. This is an exciting development for Arlington County and we thank Lonn for the information.

Legal Case Update: First Baptist Church Of Arlington

Preparations continue for the trial to prevent the FBCC from building an illegal 10-story apartment tower on the site of their current church building. This tower is to include affordable housing units (fully supported by the LVCA) and luxury dwelling units. The county is providing funds for this project, which includes a new chapel to replace the existing church. The LVCA is on record as opposing the illegal height of the proposed tower and your neighbors are dedicated to preventing its construction through legal action. A second lawsuit, not involving our neighborhood, has been filed regarding the separation-of-church-and-state; county funding of this project including a new worship space raises serious issues. The suit initiated by our neighborhood residents in opposing the height of the tower needs your support. The LVCA is not party to this suit, but strongly supports the prevention of the construction of an apartment tower in Lyon Village where the zoning does not allow such a structure. Such construction could have dire consequences for future development in Lyon Village due to the precedent that would be set.
