## Neighborhood Salvage Day Free Architectural Artifacts

On Saturday, July 8th, Lyon Village will be hosting a Salvage Day at 1839 N Herndon Street. The large brick colonial on this site is to be replaced with two new brick homes. The new homes have already been sold, but you can still get something out of the deal. The entire property at 1839 Herndon will be open for salvage on Saturday, July 8th, from 11am to 5pm. Please do NOT enter the property before this time frame.

Yes, this means you can take whatever you want for free! This includes, plants from the garden, pavers, outdoor light fixtures and more from outside house. Inside the home, any architectural details, fixtures, cabinets and the like that you can safely remove may be taken. All for free!

Please note that these items are not intended for resale. The owner of the home, Brian Normile, has generously offered this opportunity to the residents of the Lyon Village neighborhood, so that items from the property may remain in the neighborhood after the house is gone.

Please do not bring children to this event. With the commotion of materials removal, this will not be a good place for kids. Adults however, should come and find that perfect planting or architectural salvage that will add to the beauty of their Lyon Village home. There will be neighborhood volunteers in the home to help insure that things go smoothly and safely. Please check in with them before removing any property, plantings or other items from the site. Volunteers will include Martha Moore and Mark Weinress.

The hours for salvage will be from 11am to 5pm. PLEASE, do not remove ANYTHING outside these proscribed hours. This home is private property and any removal or entry outside the time period of 11am to 5pm on Saturday, July 8th could be considered illegal trespass and theft. ### Neighborhood Parking Issues

A number of folks in the neighborhood have been having problems with parking issues on Lyon Village streets. The proper procedure if your driveway is blocked is to call the non-emergency number for the Police Department. That number is 703.558.2222. A Public Service Aide (PSA) will respond; or a police officer if no PSA is available. They will issue a ticket and tow the vehicle if the driveway is completely blocked. Another means of dealing with parking issue is to extend the hours of permit parking on your block. The first step in extending the hours of permit parking is for a resident to agree to take on the role of coordinator for the request and to serve as the contact person for the County. The coordinator facilitates the collection of signatures for the petition, a copy of which is available from the County. A minimum of 60% of the households on the block must sign the petition. After receiving the petition, the Arlington County Division of Transportation office will determine whether there is evidence of overspill from outside of the neighborhood at the requested hours. At least 75% of the parking spaces must be full of vehicles and 25% of the vehicles must be from outside the neighborhood. If this criteria is met, then the hours can be extended. This process will take approximately three months to complete. For further information, please contact Sarah E. ### Marshall/Newman Amendment Vote

This November, you will vote on an amendment to change the constitution of Virginia. The Marshall/Newman amendment makes significant changes to the Virginia Bill of Rights that go well beyond Virginia's thirty year old statute that prohibits same sex marriage. Under this proposal, no civil unions, no domestic partnerships and no other legal agreements will be allowed for any unmarried couples in Virginia (gay or straight). This means legal wills can become invalidated, joint property may not be held, hospital visits can be prohibited and living in Arlington may become untenable for some folks due to the legal risks involved. Virginians may not agree on gay marriage, but many will agree that this proposed amendment to our bill of rights simply goes too far. ### Arlington Alert

This Spring's tornado warnings were announced through Arlington Alert and the various NOAA radios. But a large number of people, many women with strollers and young children, weren't plugged into those announcements. In fact, with IPODS in their ears, many weren't aware of any of their surroundings. During the announced warning period, droves of folks leisurely strolled our streets in total ignorance of nature's own warning system. When winds pick up suddenly and a very bright sky turns dark, it is time to take shelter. Just because LV hasn't had any major damage from severe winds since *Isabel*, doesn't mean that we should be casual about them. Far better to have practiced good precaution than to be found in the next county. Stay alert.

Get connected with Arlington Alert. This free cell phone text message and email alert service is available for to all. You will receive information of storm warnings, emergency notifications and major traffic alerts. Registration for this free service is at [www.arlingtonalert.com](http://www.arlingtonalert.com). Arlington Alert is now also available on XM Satellite Radio Channel 214. For those without computers or cell phones, the Arlington Alert information is available at radio stations 1500 AM; 630 AM; 107.7 FM, it is also at cable television station Arlington Virginia Network (AVN) 74. Please take advantage of this information. And, if you have elderly neighbors who might not be connected to this information, please check on them to make sure they have the info. Be safe!

### Influenza

The Office of Emergency Management and Public Health recently held a session with an overview of Arlington's plans in the event of an influenza pandemic. While there is no pandemic at present, two of the three criteria for a pandemic influenza have been met: a new strain of influenza has developed and the strain causes severe illness in humans. The third criterion has not been met; this new strain cannot spread easily from person to person. There is very recent evidence however of human to human transmission in Asia. The federal government has asked all local regions to develop plans for both a mass inoculation (providing there is enough vaccine available) and control of the medical resources when a pandemic occurs. These plans will include not only local populations in a neighbor to neighbor setting, but also business applications as it is assumed that 50% of an affected population, including medical and civil responders, will be out of commission in any of the series of waves that influenza occurs in.
