Playground Park Meeting

On April 11th, Nancy Gaito, our LV park representative met with County Park staff to discuss neighborhood concerns regarding the park. Emails sent by members of the neighborhood were included in the discussion. Addressing concerns regarding the fencing, the County noted that all the fencing will be replaced and new gates installed at the existing entries beginning this month. The county agreed to delay the opening hour on the water feature to 9am. The feature will be shut off at 8pm. A neighborhood proposal to have a break during the day was not accepted. However, signage will go up on rules regarding use of the water feature.

A Greener Entryway

Do you leave your front porch light on all night for security? Replace your 75-watt standard bulb with a compact fluorescent bulb using just 18 watts for the same amount of light, and save energy and money. The standard bulb will use about 329 kwh of electricity in a year versus the new bulb using only 79 kwh, for a savings of about \$16/year at current Dominion rates of 6.5 cents/kwh. And, the new bulb won't need replacing for 6-8 years.

County Files Response in Suit Over Zoning Changes

The plaintiffs in the suit regarding the major zoning changes enacted by the County to allow a 10-story high-rise to be built on the edge of Lyon Village, recently received Responses to the complaint that was filed a few weeks ago. Many individuals in our neighborhood are contributors to the fund to proceed with this legal action, as is the Lyon Village Citizens Association. As most know, the controversy is over a 10-story building proposed for the site of the First Baptist Church at Clarendon, at the intersection of Highland and Hartford Streets. The site is not zoned for this height, and to push the project through, the County Board, with the exception of Paul Ferguson voted to change Arlington zoning law to allow for rapid rezoning of single-family residences to high-rise development.

As expected, in their separate Responses to the complaint, the County and the FBCC are trying to deny a court hearing by asking that the case be dismissed largely on the basis that the plaintiffs, as mere citizens, are not entitled to second-guess the motives and actions of the County Board. The view at the County Board appears to be that the Courts should not be permitted to second-guess the County. In the previous suit filed over the rezoning of this site, the Virginia Supreme Court made it very clear that the Courts do have that right, and ruled that the County could not capriciously do as it pleased with zoning law.

Two items in the County's response deserve special mention. First, it may be remembered that our community worked to alert other neighborhoods that the proposed zoning changes were not limited to Lyon Village and Clarendon, but could be used countywide to rezone residential property to C-R and build to 125 feet. The County asserted that the zoning changes would apply only to the Church property, and perhaps a few other properties in Clarendon. This helped to dissuade other neighborhoods from becoming involved. In the County's recent response however, they now admit that the C-R amendments are to be "applied Countywide and thus to any and all properties zoned C-R at that time or in the future." It should be of great concern to Arlington's neighborhoods that a formal notice issued by the County misled the community about the scope of a measure being proposed, based on County's own current statements.

Second, our neighborhood took issue with the County Board's unprecedented and undue haste in its action on the zoning changes. Haste that appeared to be a ploy to keep citizens from being fully apprised of the scope and consequences of the enormous changes being proposed. In its recent Response, the County simply dismisses the *Arlington Way*, justifying its haste by claiming that the traditional way of doing things in Arlington can be ignored because it is nothing more than "merely a nebulous feeling or expression" and that there is no need for things like "planning commission work sessions, meetings of advisory bodies such as Site Plan Review Committee, or citizen task force meetings."

Needless to say, the attorneys moving forward in this suit against the County have a lot to do. Contributions are needed to help protect Lyon Village and Arlington from the recently approved zoning changes. Local Artists and Art in Arlington

Since 2000, the Arlington Artists Alliance has been bringing Arlington artists together and bringing their work to the community. Founded by working artists, the Alliance organizes exhibit space for Arlington's visual artists, maintaining revolving exhibits of members' work in a variety of public and commercial locations—Cassatt's Kiwi Café, Così at Courthouse, Scoops Beaugard, the Arlington County Board offices, Arlington Judicial Chambers, Arlington Free Clinic, Arlington Food Assistance Center, and more.

Any artist living in or maintaining a studio in Arlington and working in two-dimensional drawing, painting, multi-media, or print-making or three-dimensional ceramics, woodturning, or glass is welcome to join. All levels of experience are welcome—student, hobbyist, emerging artist, or professional. Each exhibit venue has a curator who screens all work for quality.

In addition to its revolving exhibits, the Arlington Artist Alliance sponsors several large shows each year and the annual Spring ArtFest—a week-long schedule of workshops and demos design to engage the community in making art as well as viewing it.

The Alliance sponsors a number of community service projects—mural painting, art projects with Argus House residents, the Scholastic Art Awards Program for high school students (a national competition), and a High School Artists Mentoring Program which has provided at-risk students with one-on-one experience with an Alliance member who is an established, practicing artist—as well as participating in community events such as Clarendon Day, Neighborhood Day, and the Arlington County Fair.

The Alliance also operates the Arlington Artists Academy which offers art instruction to adults, youth, and children and summer art camps for youth and children.
