### Presentation on Local Real-Estate Market Update on Dominion Virginia Undergrounding Project

At this month's General Meeting we will have local real-estate expert and Lyon Village resident, Ingrid Wooten and possibly others to discuss the state of the Arlington real-estate market with a special focus on Clarendon and Lyon Village. Our area has been very lucky in the midst of the real-estate downturn, with values down only slightly (see article on tax assessments below). There have been subtle shifts in the market, and in the relative strength of single-family versus condominium homes. Come to the meeting to hear what Ingrid sees next for our market and what steps to take if you're looking to eventually buy, sell, or improve a home in the neighborhood.

Also at the February meeting, Carla Pickard of Dominion Virginia Power will provide an update on Dominion's undergrounding project. We've all experienced the construction issues on Kirkwood Road; this will be chance to find out about the schedule and progress on this work. Once this work is complete, we have to hope that the county will repave the portions of Kirkwood not affected by Dominion's construction work. In addition, this presentation will provide an opportunity to get news on the next area of work, Lee Hwy facing Lyon Village. The result of all this work will be 2.5 miles of 69 kV underground lines from both the Nelson Street and Wilson Boulevard substations connecting to the Rosslyn Substation at 1850 N. Moore Street. These are essentially high-tension lines buried underground. These improvements were necessitated by the growing power demands in our locale and will allow for better distribution of electricity.

#### **Tax Assessment Time**

It's that time of year when we receive our tax assessments. Our neighborhood housing market must be doing well; there are reports of many assessments in Lyon Village going up, a few by large amounts. Some are questioning rising assessments when all we hear about is the continued downturn in the housing market. While most assessments are down, there are cases in and around Lyon Village where increased assessments this year are adding upwards of \$100,000 and even \$200,000 in assessed value to the homeowner's annual tax bill.

Property in Arlington is assessed as of January 1 of each year by the Department of Real Estate Assessments. The Arlington County Board sets the tax rate at the end of April. The rate for tax year 2008 is .848 per \$100 of assessed value. The 2007 rate was .818. Board Chair Barbara Favola, a 12-year veteran of the board, said it would be very hard for the county to stick to its previously stated goal of keeping the average tax bill unchanged. "My guess is that it's not going to be possible," Favola said. "We're probably going to have to ask our residents to pay a little more." The county spends about \$1 billion on county programs and schools.

Over the past year, county statistics show overall real-estate values in Arlington as essentially flat. In Arlington, the average value of a single-family home declined by 2% to \$520,100 from \$530,800. Commercial properties in the county increased in value by 2.3%.

Given the 2% decline in single-family home values, most Arlington residents saw a decrease in their county tax assessment, as would be expected. Assessed value declined for 65% of Arlington homeowners. Of those, 52% saw a decline of 2% or more. The remaining 45% saw no change or an increase in their assessment. Some 16% of homes had no change, while the remainder showed an increase.

Of the properties with an increased assessment, 13% increased up to 3%. There were 6.5% that saw an increase of more than 3% in their assessment, with some seeing increases of over 20% despite making no improvement to their property over the past year. Overall, residential assessments decreased an average of 1.2%, with a 2.1% decline for existing properties offset by a 0.9% increase for new construction/conversions.

The first step in challenging an assessment is to phone the Department of Real Estate Assessments and ask to speak to the appraiser assigned to your neighborhood. If not satisfied after speaking with the appraiser, an appeal form, provided by the Department of Real Estate Assessments may be filed. The form provides a formal request for the appraiser to reconsider the value determination.

If the departmental review doesn't provide satisfaction, an appeal may be filed with the Board of Equalization of Real Estate Assessments. This is a five-member citizens' group appointed by the County Board to mediate differences of opinion between property owners and the Department of Real Estate Assessments.

Once the Appeals of Board of Equalization decision has been rendered, the next option is to file an appeal with the Circuit Court of Arlington. For further information, contact the Department of Real Estate Assessments at 703-228-3920.

#### **TSA Updates**

Transportation Safety The Administration (TSA) will be making some changes to security procedures in the next few months. Important among these changes is that your name on your ticket must appear exactly as it appears on your driver's license or passport. Previously, so long as your first and last name was correct, that was enough. With the new changes, if your driver's license says John Q. Smith - then the ticket will have to read John Q. Smith, not just John Smith. For those who travel often and have frequent-flier numbers, make sure that they are in the exact same name as on your driver's license and passport. You will now also be required to provide your date of birth and your gender (thank you to Joan Porte, CTC at <u>www.joanstravelpartners.com</u> for providing this information). #### A Lyon Village Neighbor's Hard-Drive Saga
