### Watch out for ...

**Aggressive towing.** A Lyon Village resident recently parked in front of the Walgreen's at Kirkwood and Lee Highway and went inside to shop. While shopping for 10 minutes, her car was towed by Advance Towing, which claimed she had gone into Tarbouch next door. She had not, as was confirmed by the Walgreen's employees. The Walgreen's manager directed Advance to return her car. The Arlington police were called and confirmed it was an illegal tow and worked with the resident about remedies.

**Sales scams.** In early June, an LV resident at 18th and Adams reported that a man in a van with "Omega Meats" signage and N. Carolina plates knocked on her door and attempted to sell steaks. This was a scam. The resident notified the police. An Arlington County Solicitor's License is required to sell door-to-door.

**Foxes.** In mid June, an LV resident reported that she and her dog were chased by a wild fox that appeared sick and/or rabid. This occurred at 11:30am near the intersection of 20th and Hancock. The resident called the police.

## Development Update

**2311 Wilson Blvd. (Listrani's pizza site).** A meeting was held with the developer and county staff to consider designs for the relocated pedestrian path that currently bisects the site. A Site Plan Review Committee (SPRC) meeting is scheduled for July 29.

**2401 Wilson Blvd.** The developer of this proposed hotel and four single-family houses at Adams St. and Wilson Blvd. has made changes requested by county staff. The developer consulted with LVCA on the project and has our support. A SPRC meeting was held on June 17. Additional meetings will be scheduled.

**Zom.** Construction is now above street for this project at Washington Blvd. and Ivy St.

**Washington Blvd. and Highland St.** The builders asked the Clarendon Courthouse Citizens Association if they would consent to overnight construction hours. CCCA objected (supported by LVCA) and the request to the county was withdrawn.

**James Hunter Park (aka the dog park).** Construction was scheduled to finish in July at I 3<sup>th</sup> and Herndon St.

**Clarendon Metro Plaza.** The first phase is complete and the bike rack canopies have been installed. The repaving of the rest of the park to the war memorial is scheduled for completion in late summer. The existing wooden benches will be refurbished and reinstalled. The movable furniture installed during phase one has been temporarily removed by county staff until they can figure out how to reduce theft of the items.

## Keep Sidewalks Clear

As a courtesy to neighbors — especially those with baby carriages or wheelchairs or the elderly — please keep your bushes and trees trimmed back off the sidewalks. And it's the law:

*§10-15. Duty of Each Property Owner or Occupant of Property to Cut Back Obstructing Vegetation.*

*It shall be the joint and several duty of each owner or occupant of property to cut back or remove trees or parts thereof, hedges, shrubs, vines and other vegetation which encroaches upon any sidewalk, alley, roadway, street or highway and which impairs or obstructs and pedestrian or vehicular traffic. Such growth higher than ten (10) feet above the surface of a walk or roadway need not be removed unless such growth creates a health or safety hazard. (2-21-81; 4-24-82; Ord. No. 96-7, 5-11-96)*

## Noisy Work Hours

Please be aware that the county limits the hours during which noisy work can be performed, from 7am - 9pm weekdays and 10am - 9pm weekends and holidays. These hours apply to all work that makes noise, not just major construction projects. Noisy work includes lawn work, home repairs, etc., whether it's being done by a contractor or the homeowner. It is each homeowner's responsibility to ensure that workers in your employ understand and adhere to these hours. On weekdays, you may contact the Code Enforcement Office at 703-228-3232 to report a violation. On weekends and holidays, you may call the Police Non-Emergency number, 703-558-2222, and an officer will be dispatched to the site.
