## Trash and Recycling Bins Can Not Be Left at Curb

County Code Chapter 10-6, Section b, Storage, Removal and Maintenance states: Place all refuse and recycling carts, household containers, bundled material, bundled brush, and plastic bags at the collection point no sooner than 5:00 p.m. the day prior to, nor later than 6:00 a.m. of the day of scheduled collection, and remove all household containers to their normal storage location within twenty-four (24) hours after emptying. Normal location shall mean a regular place of keeping not in front of the dwelling and/or behind the front building line that faces any County street, unless there is fencing or landscaping that screens or shields the containers from general view from the street.

County Code Chapter 10-11 states: Unless otherwise provided herein, it shall be unlawful to violate any of the provisions of this article and any person who violates any of them shall, upon conviction, be subject to a fine not to exceed three hundred dollars (\$300.00) for each violation.

Arlington County's Natural Resources Division is providing a variety of native tree species for residents. Distribution is at the Arlington County nursery facility from 8am-3pm. The nursery is located in South Arlington on South Four Mile Run, behind Barcroft Field #6. The trees being distributed are generally termed "whips" in the nursery trade and are in two-gallon containers. Tree height varies with species but generally ranges between two to four feet.
