General Meetings

Our General Meetings are over for the year. The next one will be Monday, March 13, at 8 pm at the Community House.

Streets Update

As a follow-up to the November General Meeting, Tom Hutchings of the County staff has provided answers to questions raised by LV residents.

- The requested improvements to 13th St. off Kirkwood Road were funded in September 2015 and are now in preliminary design. <https://arlingtonva.s3.amazonaws.com/wp-content/uploads/sites/5/2016/09/Project-Status-BR2-Sep-2016.pdf>
- While a request for pedestrian striping and or a 4-way stop sign at 13th St. and Hudson St. is under review, the current traffic counts do not warrant a 4-way stop at this location. Mr. Hutchings stated at the meeting that without sufficient vehicle volumes, accident rates typically go up. Drivers tend to run the stop sign in both directions.
- In response to questions such as what the traffic signal options are for Washington and Wilson Blvds., whether there will be a protected left for westbound Wilson Blvd., and whether u-turns will be allowed in front of the War Memorial, Mr. Hutchings responded as follows. Westbound Wilson Blvd. turning left onto Washington Blvd. will remain as currently designed, allowing yield lefts. Clarendon streets provide additional options to turn left onto Washington Blvd. such as Highland Street and Garfield Street for vehicles going south on Washington Blvd. Traffic engineering is also modifying northbound Washington Blvd. traffic to restrict lefts onto westbound Wilson Blvd. Traffic heading west on Wilson mostly uses 10th Street now and the northbound Washington Blvd. left turn count is relatively low. <https://arlingtonva.s3.dualstack.us-east-1.amazonaws.com/wp-content/uploads/sites/31/2014/03/DES-Clarendon-Multimodal-Transportation-Study-Presentation.pdf>, <https://arlingtonva.s3.dualstack.us-east-1.amazonaws.com/wp-content/uploads/sites/31/2014/03/DES-Clarendon-Multimodal-Transportation-Study.pdf>
- The dilapidated house by 13th St. and Jackson St. is scheduled to be acquired by the county this winter as part of the reconfiguring of the Washington Blvd. and 13th St. intersection. Demolition is scheduled for July 2017 after the furniture repair building is acquired.
- A request for more handicapped street parking spots at or near Wilson Blvd. and Hudson St. is under review.
- Lyon Village noted our support for making the 10th St., Fairfax Drive, and Kirkwood Road intersection more pedestrian friendly. This project is a future Planned Capital Improvements Project, but has not yet been fully scoped or funded.

Development Update

2311 Wilson Blvd. – Clean Technology Building. Concrete is being poured for the foundation and structure below street level. While the pedestrian path around the site is closed, the alternative paths to Wilson Blvd. are along Adams St. next to the Hyatt Place Hotel or through the Key School parking lot to Veitch St.

Sport & Health site. The Dec. 20th Long Range Planning Committee meeting determined to increase the scope of the Special General Land Use Plan Study to include all the commercially zoned parcels on the block. The next LRPC meeting will be scheduled this winter.

Red Top Cab development. No word on a construction start date for the block bordered by 13th St., Washington Blvd., and the Beacon apartment building.

Christmas Tree Collection

During the first two full weeks in January, Christmas trees are collected curbside for residential homes with trash and recycling service. Residents are reminded to place the tree on the curb no later than 6 a.m. on your regular trash collection day and to remove all decorations, nails, stands and plastic bags. The trees are later ground into wood mulch for garden use. After Jan. 13, please prepare the tree for yard waste collection on your regular trash collection day.

Christmas Tree Drop-Off

Residents who don't have curbside recycling service, such as those living in townhomes, apartments or condominiums, may also bring their Christmas trees to the Solid Waste Bureau during the Christmas tree collection season. Call 703-228-6570 to schedule an appointment, Mon.-Fri., 8 a.m.-3 p.m. Residents will need to show proof of residence in Arlington, such as a driver's license.
